Payments

You are required to pay 50% of the total price before work can begin on your vehicle. Should your project take 3 months or longer to complete, you will be invoiced, against your deposit, for material and labor used on your vehicle as your project progresses. When the 50% deposit is used up, you will be asked to make an additional 25% deposit to bring the total deposit to 75%. When the 75% deposit is used up, you will be asked to make an additional 15% deposit to bring the total deposit to 90%. The 10% balance is due when the vehicle is complete. Customer Provided Parts

When the customer agrees to provide materials for restoration, they must do so in a timely manner (usually 30 days). If materials are not provided timely, Silver State Industries reserves the right to stop work on your project and bill for work performed. In addition customer will be subject to a outdoor storage charge of \$35.00 per day. INT. _____

Old Parts

After a build or repair is completed leftover parts used or otherwise, not specifically asked for by the customer, will be stored and returned to them upon request for a period of 30 days. After 30 days, parts will be considered by Silver State Industries to be abandoned and will be disposed of at the expense of Silver State Industries. INT. _____

Warranty

Silver State Industries provides: a two (2) year manufacturer warranty on PPG paint, a one (1) year warranty on paint and upholstery labor, a ninety (90) day warranty on electrical and mechanical labor. We do not warranty customer supplied parts or other manufacturers parts and materials. Since Silver State Industries is a training facility located in a prison, completion of your project can be delayed because of training or security issues. Completed restorations are not show quality. All warranty work to be done in our shop only. This does not include towing charges or customer supplied parts. Neglect/abuse of vehicle will immediately void any and all warranties. INT. _____

Silver State Industries will provide a written statement to each customer for repairs, supplemental repairs, and replacement parts used in the repair. Replacement parts, OEM (Original Equipment Manufacturer), Aftermarket, or LKQ (Like Kind and Quality Salvage), will be clearly identified, on our estimates and repair order. Insurance companies may require the use of parts listed above. OEM, Aftermarket and LKQ replacement parts will be warranted by the manufacturer or supplier. INT. _____

Additionally, we are not responsible for any items left in the vehicle at time of repair.
