This Automobile Appraisal report consists of two sections: *A Vehicle Identification Section* and *A Vehicle Evaluation Section*.

### **Vehicle Identification Section**

The *Vehicle Identification Section* provides you and the appraiser with detailed information about your vehicle. This information helps the appraiser to research your vehicle accurately and provides the foundation for a precise and reliable appraisal. You should examine the information in this section for accuracy and inform the appraiser of any changes.

### **Vehicle Evaluation Section**

The *Vehicle Evaluation Section* reports the results of the evaluation conducted by the appraiser. This section begins with the appraiser's comments about the overall appearance of your vehicle. This is followed by the detailed 320-point evaluation which includes the *component* examined, the range of points and the appraiser's *grade*. The component is the item on your vehicle that is being evaluated, such as the front driver's seat or exhaust system. Next comes the range of points available for the components being examined. Then comes the grade for your vehicle's component; the lower the number, the less your vehicle's component resembles a new-vehicle's component. The actual numbers that define the range are based upon the relative cosmetic or mechanical significance of the component. For example, your vehicle's chrome quality counts more than the quality of the windshield wiper blade; therefore the maximum points awarded for chrome is higher. The grade is the appraiser's subjective evaluation of the component on your vehicle. A maximum award means that the component is the same quality as found on a new model vehicle.

When no component exists for your vehicle, the appraiser enters "N/A" (not applicable) under grade. When a component is missing because it has been removed, the appraiser enters "M" (missing) under grade.

When totaled, N/A scores are not counted in the category called "*Adjusted Total Possible Points*". Therefore they do not count against your vehicle. (For example, a two seater would not lose points because it lacked a back seat.) Missing components however *do* count against your vehicle. When a component is missing, the appraiser subtracts the maximum number in the range from your vehicle's potential total.

If your vehicle has some special historical significance, the appraiser is free to add a dollar value based on the authenticity of the information provided. At your option, the appraiser can also add points depending on the results of a test drive.

To determine your vehicle's value, the appraiser takes the total possible points and corrected vehicle grade and compares them to arrive at a percentage. The percentage is then applied to the value of a "perfect" vehicle. A perfect vehicle is a car similar to yours but in perfect condition with maximum options. Once the appraiser determines the grade of your vehicle and the value of a perfect vehicle, he can calculate the value of your vehicle. This number is found at the end of the report.

## NOTES

ENGINE COMPARTMENT	Numbers matching 350 four barrel and four speed manual transmission. The engine and compartment are in factory condition with the exception of some minor browning of the exhaust manifolds. The owner removed the original panel above the radiator when the vehicle was new and carefully stored it to preserve the factory decals. A factory replacement has been installed. The original battery has been stored.
TRUNK	The interior of the trunk compartment has its factory finish in excellent condition. The original spare, jack and tools are in excellent unused condition.
UNDERNEATH	In factory condition with the exception of dealer applied undercoating when the vehicle was delivered. All suspension components have factory finishes and inspection marks. The exhaust is in new condition.
INTERIOR	The interior is in pristine original condition. An aftermarket stereo was installed in the console as well as speakers in the door panels when the vehicle was new. The original console and door panels were removed and carefully stored. Factory replacements were used for the stereo installation.
BODY	Straight original low mileage body that has been in heated storage and has never had any rust or collision damage.
PAINT	Vehicle has its factory applied paint and has no chips or scratches. The stripes are in excellent condition.
WHEELS	Original 15 inch Z28 aluminum wheels with the factory finish. The wheels and centers are in excellent condition.
TIRES	Four B.F. Goodrich P225/70R15 in new condition. The owner removed the four original Uniroyal P225/70R15 when the vehicle was delivered new. They are vacuum sealed and stored.

GLASS	All glass is original and has no chips or scratches.
TRIM	All trim pieces, emblems and light lenses are original and in excellent condition.

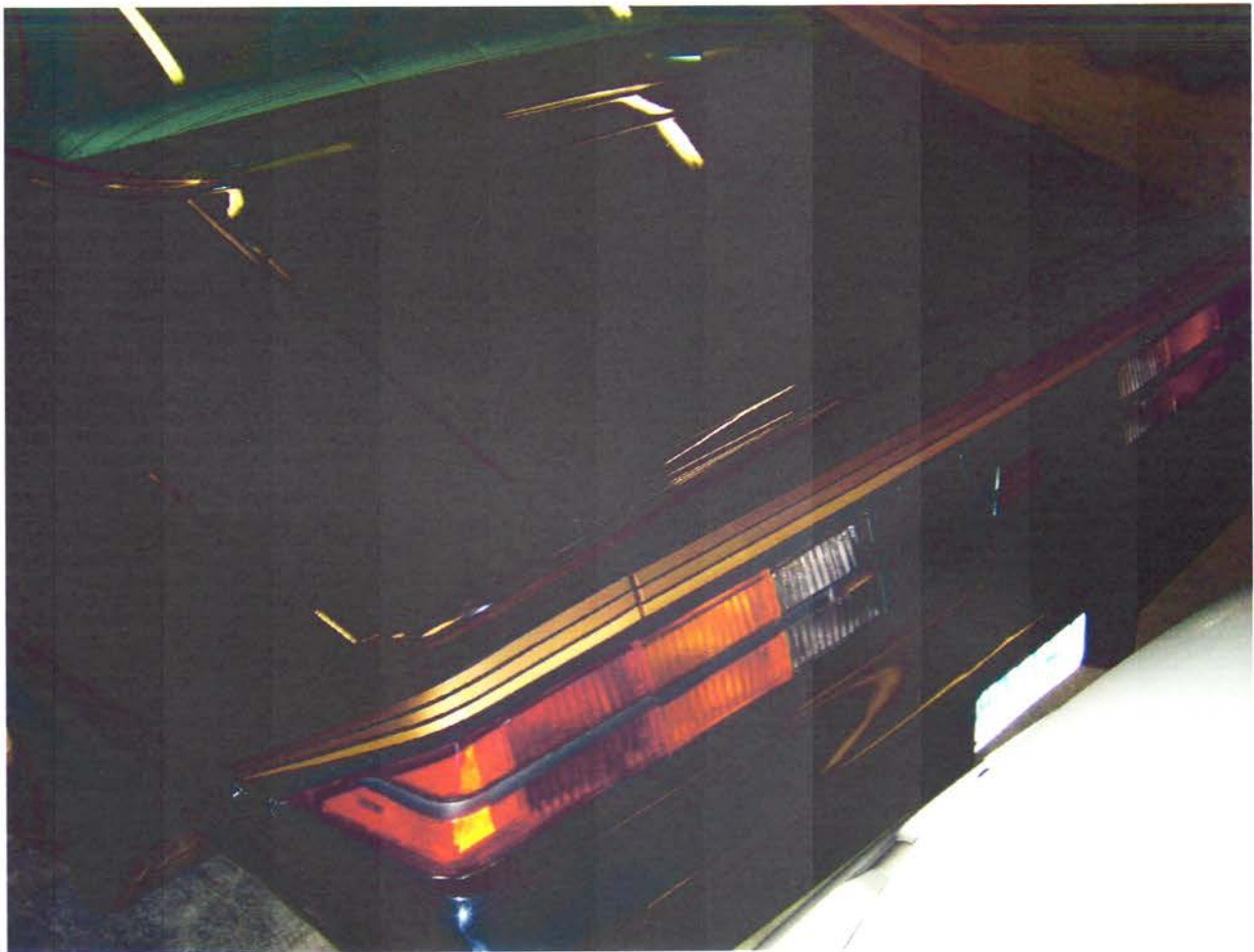
**Comments:**

Very nicely preserved vehicle. The only demerits from factory new condition are some browning of the exhaust manifolds and dealer applied undercoating.

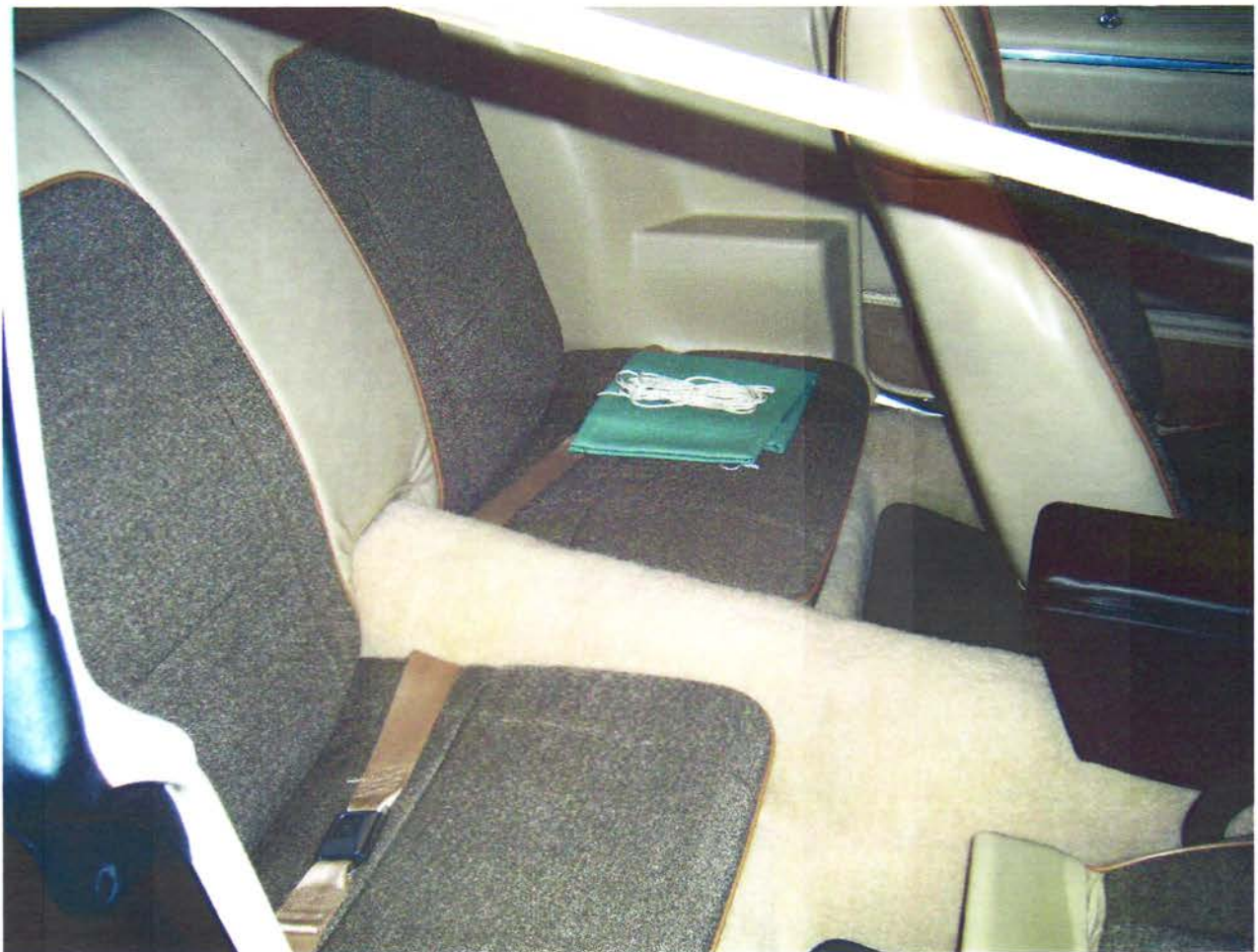
